

# Conference format



Similar to previous years, the Conference ran over five days, comprising two days of professional development workshops and two-and-a-half days of conference sessions (a combination of three plenaries and six parallel sessions).

Poster presentations were held on Wednesday 23 October, followed by an Author's Night. The SAMEA awards took place on Thursday evening and Friday was dedicated to more parallel sessions within the six conference strands and the closing plenary. 

# Technology & communications

# Better Evidence for Public Policy & Implementation

Focus: How public sector institutions use evidence in policy and decision-making to deliver better outcomes for society.

Strand summary: Using evidence is important for improving development outcomes. We need to strengthen evidence across all sectors and stakeholders to be able to make better choices, influence policy and implement more effectively. Evidence must be disaggregated to reflect the realities of different stakeholders, particularly those marginalised.



### **MERL Tech**

Focus: Providing a platform for delegates to discuss the influence of technology on how practitioners design M&E studies, collect data, analyse information, report on and visualise data.

Strand summary: The complementary role of monitoring, evaluation, research and learning (MERL) and Technology is growing. However, with many options, it is important that evaluators grow their understanding of technology, like learning basic coding and reviewing and being critical of tech solutions offered.



### Investing for Impact

Focus: Exploring the role of M&E in impact investing and corporate social investment programmes.

Strand summary: We will not solve social problems unless everyone comes to the party. As data and knowledge agents, the M&E community may be what is needed to bridge and facilitate collaborative development. However, M&E needs to be responsive to the evolving needs in order to measure impact and share knowledge widely for adaptive management. We introduced 150 people to the practice of impact management and measurement and we encourage people to build capacity in this market.



# Climate Change and Building Resilience

Focus: Providing an opportunity to discuss how M&E helps us to assess implications of climate change on individuals, communities and organisations and through strong evidence contributes to building resilience.

Strand summary: Climate change can be intimidating because it is intangible and complex. Climate change links to all areas of activity – which is a good thing because it means we can work on climate change wherever we are. Seeing links in your own areas of practice makes climate change more tangible and do-able but we need systemic approaches and complexity-friendly M&E.



### M&E for Non-profits

Focus: Drawing lessons from how M&E is carried out in the non-profit sector and how it enables learning, how it shapes current practice and how it is adapting to changes brought about by technology, donor demands and communities' needs.

Strand summary: M&E shapes and is shaped by power dynamics between funders, NGOs, communities and M&E experts. This needs to be recognised. We must respect different ways of knowledge and different types of knowledge from different stakeholders.



### M&E skills in a Changing World

Focus: Examining the changing skills requirements for the M&E profession in the 21st century and discusses the evolving roles of practitioners.

Strand summary: Creative approaches used in teaching and training must foster experiential learning and simulate evaluation situations that unfold on the ground. We must keep up and integrate emerging technologies in our practice. We are mapping a path towards professionalization of the M&E sector and on route to mitigating the M&E skills needed in a changing world.













To what extent did the conference respond to the theme?
